- 1. Option granted pursuant to Company's 1998 Stock Option Plan ad incentive to remain in employ of Company.
- 2. Become exercisable as to 1,000 shares on each November 7, beginning November 7, 2003.
- 3. Restricted Stock Units granted pursuant to the Albany International Corp. 2003 Restricted Stock Unit Plan (the "Restricted Stock Unit Plan"). Each Restricted Stock Unit entitles the holder to receive the cash equivalent of one share of Class A Common Stock at the time of vesting or, in the event that the holder elects to defer payment, at such later time elected in accordance with the Restricted Stock Unit Plan
- 4. 400 Restricted Stock Units (plus related dividend units) vest on each November 13, beginning November 13, 2004.
- 5. 400 Restricted Stock Units (plus related dividend units) vest on each November 11, beginning November 11, 2005.
- 6. Restricted Stock Units granted pursuant to the Albany International Corp. 2005 Incentive Plan (the "Incentive Plan"). Each Restricted Stock Unit award entitles the holder to receive a number of shares of Class A Common Stock, the cash equivalent of such shares, or a combination of cash and shares, in each case in accordance with a vesting schedule
- 7. (a) 25% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2006, (b) 50% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2007, and (c) the final 25% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2008. The 2006 payment will be all in cash, while each of the 2007 and 2008 payments will be half in cash, half in shares of the Company's Class A Common Stock.
- 8. Includes dividend units accrued on Restricted Stock Units on January 8, 2007.

9. (a) 25% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2007, (b) 50% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2008, and (c) the final 25% of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2009. The 2007 payment will be all in cash, while each of the 2008 and 2009 payments will be half in cash, half in shares of the Company's Class A Common Stock.
